RESOLUTION 21-1891

**A RESOLUTION BY THE CITY COUNCIL OF THE CITY OF LAGO VISTA, TEXAS
ADOPTING AN UPDATE TO THE THOROUGHFARE PLAN; AND PROVIDING
FOR RELATED MATTERS;**

WHEREAS, in 2009, the City Council commissioned a study of the City's transportation needs, including an analysis of Lago Vista's then current street network and projected infrastructure needs based on projected growth; and

WHEREAS, the City utilized the services of HDR Engineering, Inc., whose findings were presented to and adopted by the Council on October 1, 2009; and

WHEREAS, the City has undergone significant growth over the subsequent twelve years, giving rise to the need for updates to the Thoroughfare Plan; and

WHEREAS, the City utilized the services of Freese and Nichols, an engineering, planning and consulting firm, to conduct a study and prepare an update to the 2009 Thoroughfare Plan; and

WHEREAS, at a public meeting on June 24, 2021, the Planning and Zoning Commission considered the proposed update to the 2009 Thoroughfare Plan, recommending adoption of the findings to the Council; and

WHEREAS, to assist in planning for future development within the City of Lago Vista and its Extra Territorial Jurisdiction (ETJ), it is necessary to update the existing Thoroughfare Plan; and

WHEREAS, the Thoroughfare Plan is a reflection of the current street network in the City and surrounding area along with a projection of the location and types of components that are needed to accommodate long-term growth within the City and its ETJ; and

WHEREAS, an updated Thoroughfare Plan will serve as important tool to enable the City to preserve future corridors for transportation system development and improvements as the need arises due to continued growth and development.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF
LAGO VISTA, TEXAS:**

Section 1. The foregoing recitals are incorporated into this Resolution by reference as findings of fact as if expressly set forth herein.

Section 2. The City Council hereby adopts the Thoroughfare Plan Update attached to this Resolution as **Exhibit "A"**.

Section 3. The meeting at which this Resolution was passed was open to the public, and public notice of the time, place and purpose of said meeting was given as required by the Open Meetings Act, Texas Government Code, Chapter 551.
