On April 4, 2024, the City Council of the City of Lago Vista, Texas passed and approved the following Ordinances:

### ORDINANCE NO. 24-04-04-01

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LAGO VISTA, TEXAS, AMENDING ORDINANCE 23-01-05-06, RULES OF PROCEDURE, PROVIDING FOR PUBLICATION, PROVIDING FOR PENALTIES, AN EFFECTIVE DATE, REPEALER, SEVERABILITY, PROPER NOTICE AND OPEN MEETINGS CLAUSE.

### ORDINANCE NO. 24-04-04-02

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LAGO VISTA, TEXAS, AMENDING THE EXISTING PLANNED DEVELOPMENT DISTRICT KNOWN AS THE “LAGO VISTA TOWN CENTRE” APPROVED BY ORDINANCE NO. 06-04-27-01 REGARDING THE DESCRIPTION OF PERMITTED USES AND THE REFERENCE TO THE SITE DEVELOPMENT PLAN TO GOVERN PROPOSED IMPROVEMENTS; AND PROVIDING FOR RELATED MATTERS.

AN ORDINANCE OF THE CITY COUNCIL OF LAGO VISTA, TEXAS, AMENDING SECTION 3.108 AND SECTION 3.109 OF CHAPTER 3 OF THE LAGO VISTA CODE OF ORDINANCES TO UPDATE PROVISIONS RELATED TO NFPA 70 AND THE INTERNATIONAL ENERGY CONSERVATION CODE; AND PROVIDING FOR RELATED MATTERS.
