

ORDINANCE NO. 22-11-03-03

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LAGO VISTA, TEXAS, AMENDING ORDINANCE 17-11-16-02, ARTICLE 9.2000, SECTION 9.2005 QUALIFICATIONS OF MEMBERS, PROVIDING FOR PUBLICATION, PROVIDING FOR PENALTIES, AN EFFECTIVE DATE, REPEALER, SEVERABILITY, PROPER NOTICE AND OPEN MEETINGS CLAUSE.

WHEREAS, the City of Lago Vista, Texas is a Home Rule City; and

WHEREAS, pursuant to Texas Local Government Code Section 51.001, the City has general authority to adopt an ordinance or police regulation that is for the good government, peace or order of the City and is necessary or proper for carrying out a power granted by to the City; and

WHEREAS, the City operates the Lago Vista Golf Course; and

WHEREAS, the Golf Course has recently amended its operational procedures and policies to reflect that persons purchasing a membership now instead hold a pass and thus are referred to "Pass Holders"; and

WHEREAS, to more accurately reflect the membership on the Golf Course Advisory Committee (GCAC), it is necessary to amend the GCAC membership requirements to reflect the title of those holding passes in lieu of memberships; and

WHEREAS, the City Council finds that it is necessary and proper for the purpose of promoting effective and efficient government of the City to amend Ordinance 17-11-16-02, Article 9.2000, Section 9.2005 Qualifications of Members of the Golf Course Advisory Committee to be consistent with the operational policies and procedures of the Lago Vista Golf Course.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LAGO VISTA, TEXAS, THAT:

SECTION 1. FINDINGS OF FACT. All of the above and foregoing recitals are hereby found to be true and correct legislative findings of the City and are incorporated herein as findings of fact.

SECTION 2. AMENDMENT. The City Council of the City of Lago Vista, Texas, does hereby amend Section 9.2005 regarding Qualifications of Members of the Golf Course Advisory Committee as shown in Exhibit "A." Underlined language shall be added and language to be deleted is signified by strike-through.

SECTION 3. REPEALER. All ordinances, orders or resolutions heretofore passed and adopted by the City Council of the City of Lago Vista, Texas, are hereby repealed to the extent said ordinances, orders or resolutions or parts thereof are in conflict herewith.

SECTION 4. SEVERABILITY CLAUSE. If any section, subsection, article, paragraph, sentence, clause, phrase or word in this Ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such holding shall not affect the validity of the remaining portions of this Ordinance, and the City Council hereby declares it would have passed such remaining portions of this Ordinance despite such invalidity, which remaining portions shall remain in full force and effect.

SECTION 5. CODIFICATION AND PUBLICATION. The City Secretary is hereby directed to record and publish the attached rules, regulations and policies in the City's Code of Ordinances as authorized by Section 52.013 of the Texas Local Government Code.

SECTION 6. EFFECTIVE DATE. This Ordinance shall take effect immediately upon its passage and publication in accordance with the Texas Local Government Code.

SECTION 7. OPEN MEETINGS. It is hereby officially found and determined that the meeting at which this ordinance is passed was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act, Chapter 551 of the Texas Government Code.

AND, IT IS SO ORDERED.

Exhibit "A"

Sec 9.2005 Qualifications Of Members

All members of the committee shall reside in the corporate limits of the city and have resided therein for at least twelve (12) consecutive months preceding his/her appointment; shall not be in financial arrears to the city for any reason; and shall be qualified electors of the city. The city council will consider for appointment to the committee only those persons who have demonstrated their civic interest, general knowledge of the community, independent judgment, interest and knowledge of golf courses, marketing, management and operations and availability to prepare for and attend meetings. It is the intent of the city council that members shall, by reason of diversity of their occupations, backgrounds, and experience, constitute a committee which is broadly representative of the community, and shall be reflective as follows: three (3) members who are ~~members~~ Pass Holders of the Lago Vista Golf Course, in good standing; three (3) members with strong business acumen and in good standing within the business community and one (1) without any affiliation or affinity with golf. Other than the initial selection, members shall be appointed to the committee by the council based upon the recommendation of the council liaison.
