Introduction

In September, the Police Department made significant progress on major projects. We successfully deployed our new radio system, completing all equipment installation and programming. Training on the new system will be finished in October, with the department starting to use the system later that month. We've already tested some of the equipment and have noticed a considerable improvement in our radio communications.

This month, we also made progress on our community outreach initiatives. We held the second planning meeting for our upcoming Citizen's Police Academy program and continued to refine and plan the curriculum. This program will provide our community with an inside look at how the Police Department operates. Additionally, we held a "Pop-Up" Police Department event at the Candy Bar, giving members of our community an opportunity to interact with police department members in an informal setting while also supporting local businesses.

A noteworthy achievement this month was Detective Sergeant Frank Allocca's graduation from the Law Enforcement Management Institute of Texas Leadership Command College Program. This rigorous leadership development program is completed at three universities: Texas A&M, Texas Women's University, and Sam Houston State University. It is recognized as one of the nation's leading law enforcement leadership development programs. We are very proud of Sergeant Allocca's accomplishment and commitment to continued professional development. Captain Chrane and Chief Boshears traveled to Huntsville to watch his graduation.






Calls for Service – Historical and Year-to-Date




Calls for Service – 2024 by Month


Summary


Summary

Code Enforcement is a section of our Police Department that helps maintain and improve the quality of Lago Vista's neighborhoods by operating programs that ensure public compliance with the City Building Code and other state construction codes. Additionally, we respond to customer complaints of potential code violations, initiate fair and unbiased enforcement actions to correct those violations, and educate property owners on maintaining code compliance.
