

**CITY OF LAGO VISTA, TEXAS  
ORDINANCE NO. 25-02-06-03**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LAGO VISTA, TEXAS PURSUANT TO TEXAS LOCAL GOVERNMENT CODE, CHAPTER 102, SECTIONS 102.007(b) AND 102.010, PROVIDING FOR AMENDMENTS TO ORDINANCE NO. 24-09-19-01, FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2024 AND ENDING SEPTEMBER 30, 2025; PROVIDING FOR SAVINGS, SEVERABILITY, AND EFFECTIVE DATE.**

**WHEREAS**, the dollar amount for Professional Services in Human Resources was not properly allocated as originally requested for in the FY24-25 Budget; and

**WHEREAS**, the dollar amount for Supplies in Aquatics was not properly allocated as originally requested for in the FY24-25 Budget; and

**WHEREAS**, this amendment involves properly allocating the \$20,000 for Professional Services in Human Resources, as shown Exhibit A; and

**WHEREAS**, this amendment involves properly allocating the \$4,000 for Supplies in Aquatics, as shown in Exhibit A; and

**WHEREAS**, this proposed budget amendment to properly allocate these funds is in the best interest of the municipal taxpayers and is for a municipal purpose.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LAGO VISTA, TEXAS:**

**SECTION I  
AMENDING BUDGET**

**THAT**, pursuant to Vernon's Texas Codes Annotated, Local Government Code, Chapter 102, Section 102.007(b) the City Council of the City of Lago Vista, Texas hereby amends the City Budget by Department for the Fiscal Year beginning October 1, 2024 and ending September 30, 2025 with said amendments being as set forth in "Exhibit A" attached to this ordinance.

**SECTION II  
SAVINGS CLAUSE**

**THAT**, any ordinance, or parts of ordinances in conflict with this ordinance are hereby repealed to the extent of said conflict.

**SECTION III  
SEVERABILITY CLAUSE**

**THAT**, if any word, phrase, sentence, paragraph or section is found to be illegal, invalid or unconstitutional, the remaining portion of this ordinance shall remain in full force and effect.

**SECTION IV  
EFFECTIVE DATE**

**THAT**, this ordinance shall take effect and be in full force immediately upon its final passage and approval.
