

**RESOLUTION NO. 25-2117**

**A RESOLUTION REQUESTING CAPITAL METRO TO  
PROVIDE FULL TRANSIT SERVICE TO ALL OF LAGO VISTA**

**WHEREAS**, the City of Lago Vista is a member of the Capital Metropolitan Transportation Authority (CapMetro) and contributes 1% of its local sales tax revenue to CapMetro for public transportation services; and

**WHEREAS**, despite contributing 1% of all local sales tax revenue to CapMetro, residents of certain areas within Lago Vista do not receive CapMetro service, sometimes even being denied access on the opposite side of the same street where service is provided, creating an inequitable distribution of transit benefits; and

**WHEREAS**, the lack of comprehensive service coverage means that many Lago Vista residents are effectively paying for a service they do not receive, resulting in an unfair financial burden on taxpayers; and

**WHEREAS**, Lago Vista's geographic and infrastructure growth demands a reassessment of CapMetro's service map, ensuring that every resident who pays into the system has access to transit options that meet their needs; and

**WHEREAS**, CapMetro has a history of prioritizing regional transit projects over smaller member cities, as evidenced by its funding allocations toward initiatives like Project Connect in Austin;

**WHEREAS**, the City of Lago Vista maintains roads that CapMetro buses use, yet does not receive a proportionate reinvestment in transit services to offset the cost of infrastructure wear and tear;


**NOW, THEREFORE, BE IT RESOLVED THAT:**

1. The City of Lago Vista formally requests that CapMetro expand its service area to cover the entirety of Lago Vista, ensuring every resident who pays the transit tax has equal access to public transportation services.
2. The City of Lago Vista requests that CapMetro conduct a comprehensive service coverage review and publicly present its rationale for any areas within Lago Vista that are currently unserved or underserved.
3. The City of Lago Vista requests a timeline for implementing full-service coverage across the entire city, with adjustments made to ensure equitable service access for all residents.
4. The City of Lago Vista requests that CapMetro provide annual service reports, detailing ridership data, service expansion considerations, and potential obstacles preventing full transit coverage.
5. The City of Lago Vista calls upon other CapMetro member cities to review their own service coverage issues and collaborate in advocating for more equitable funding and service distribution across the transit system.


