



City of Leander City Council Seeks Citizens to Serve on City Boards & Commissions

The Leander City Council is currently accepting applications from citizens interested in volunteering their services to fill unexpired terms on City Board & Commissions. Current boards with vacancies include the Board of Adjustments, Leander Public Arts & Culture Commission, and Planning & Zoning Commission.

To be eligible to serve on City boards, one must be a resident and a registered voter of the City of Leander. To be eligible to serve on the Planning & Zoning Commission, one must also be a resident of Leander for a minimum of one year.
