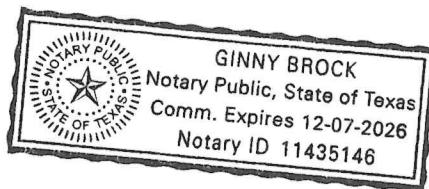

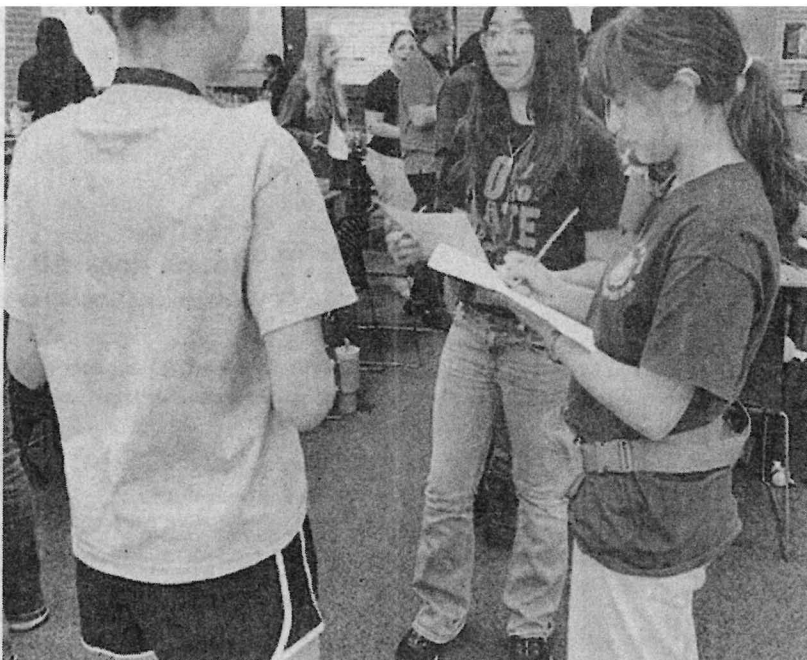

"He admitted his wrongdoing, he resigned before we could terminate him, and then later took his own life," Irwin said. "We want to be clear, this criminal is fully to blame for his crime."

Irwin went on to state that attorneys representing the victim "have not threatened to sue the criminal or his estate. Instead, they demand that city taxpayers pay them, because these lawyers are blaming someone other than the man who committed this horrible crime."

In a notice to the city, the victim's attorney blamed Cedar Park Police Chief Mike Harmon for having a policy of "reckless and deliberate indifference."

"This long-standing municipal policy systematically encouraged sexual assaults by ignoring and refusing to investigate complaints known to the Police, effectively doing nothing in response," the notice from the victim's attorneys said. "Despite prior complaints from other women known to the department, no corrective action was taken, foreseeably resulting in our client's abuse."
